

Financial Education Program Empowers Members and Changes Lives

As a membership benefit, members who need money management assistance can meet with our certified financial counselors at no cost to



develop a customized plan, giving them the tools needed to gain financial confidence. More than 600 members visited with our financial counseling team.

Many of the members served by our financial counselors have loans at risk of falling behind due to changes in their financial situations. A monthly average of \$768,000 in loan dollars was protected for members who benefitted from our financial counseling service. For Meritrust members who had loan accounts elsewhere with higher interest rates, our team was able to restructure their loans and bring over \$930,000 loan dollars to Meritrust – allowing our members to better manage their loan amount through lower interest rates and/or more practical terms.

Students Learn about Money Management at Financial Bootcamps

Budgeting can be fun! Meritrust hosted 366 students at our free financial bootcamps this past summer in all our communities. These day camps featured lessons on saving, budgeting, goal-setting and planning, with some outdoor summer camp activities along the way.



Financial Report

Meritrust remains financially strong, well-capitalized and is fully committed to further expanding and enhancing our products and services to meet the changing needs of our 90,000 members. In 2016, new loans totaled \$570.4 million, increasing total loans outstanding to \$1.11 billion, an increase of \$131 million, or 13.4%, from 2015. Member deposits grew by \$101 million, or 10.7%, bringing total deposits outstanding to \$1.05 billion. Total assets ended the year at \$1.27 billion. On total revenue of \$71.4 million, Meritrust generated net income of \$8.1 million, representing a return on average assets of .68%. Our capital ratio remained a strong 9.29%. Meritrust volunteers, working with management, actively lead and influence our financial performance and regularly monitor national and local economic conditions, develop policies, determine long-term financial objectives and monitor ongoing financial performance.




Supervisory Committee Report

The Supervisory Committee is appointed by the Board of Directors and serves Meritrust Credit Union members by ensuring that the credit union operations are effective in protecting credit union assets and financial statements are accurately reported. The Committee fulfills its obligation by monitoring the effectiveness of internal controls, adherence to established policies and procedures, compliance with regulatory requirements and propriety of financial accounting and reporting. A comprehensive 2016 year-end audit was completed by the Certified Public Accounting firm of Doeren Mayhew, CPAs & Advisors (formerly known as Orth, Chakler, Murnane & Co.). Meritrust received an unqualified opinion from our auditors on the propriety of our financial statements.
